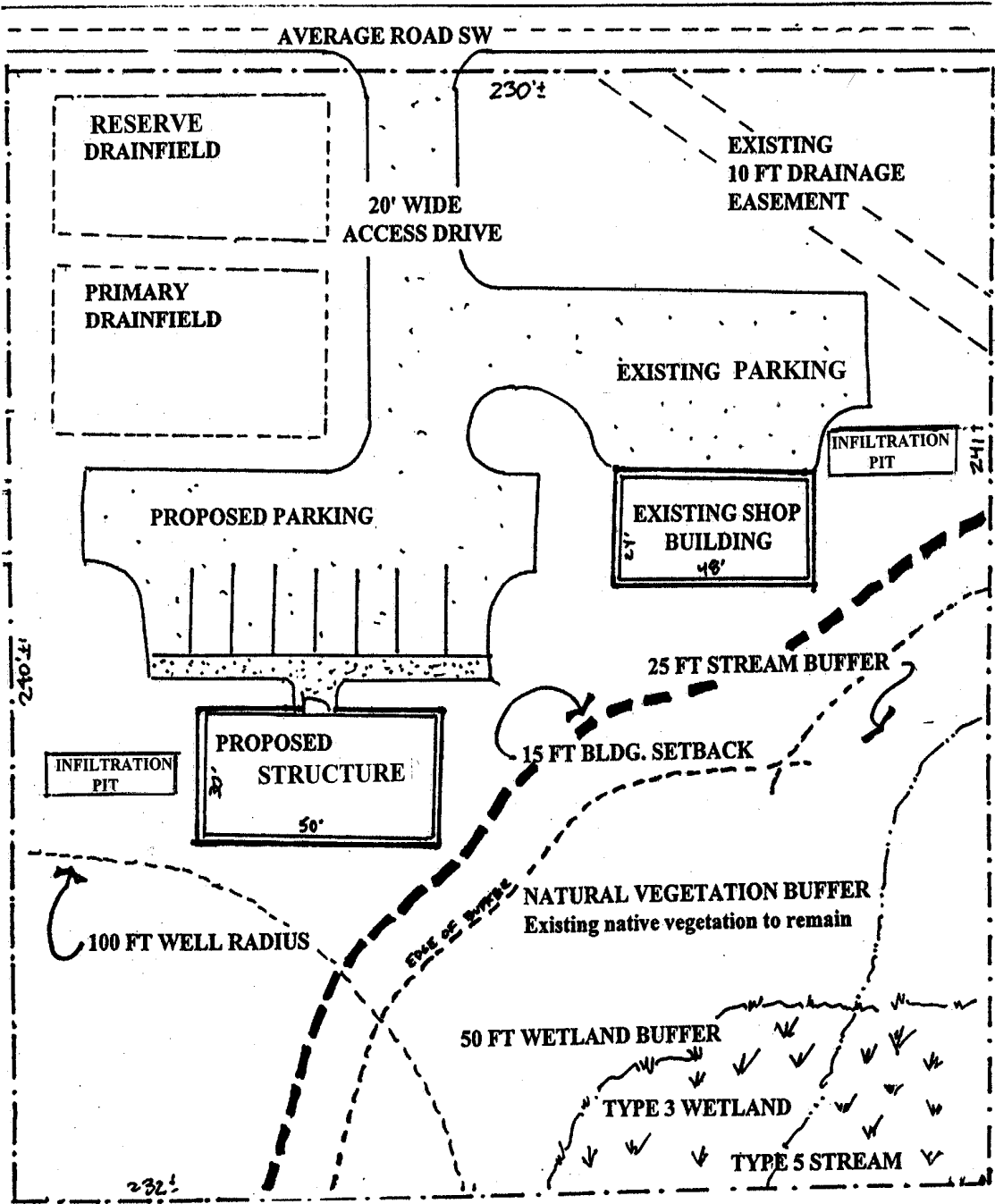
**PLAN REQUIREMENTS FOR PRE-APPLICATION MEETING**  
**(See Back for example)**

The site plan shall include the following items:

- a. Drawings shall be drawn to Engineer's scale
- b. North arrow
- c. Vicinity map
- d. Property lines and dimensions
- e. Show all existing and proposed:
  - **Buildings and Structures** with all number of stories & total square footage.
  - **Right-of-Way, Streets and Roadway easements, driveways, buildings** with setbacks from property lines.
  - **On-site sewage disposal systems** (septic tank, pretreatment devices and drainfield), including 10 foot no-build zone(s) **Arrow** showing direction of slope in drainfield area.
  - **Well and well radii** including those on adjacent property, that are within 100 feet of any proposed or existing drainfield on subject property.
  - **Buffers, open space, fences, sidewalks, parking areas, and Storm drainage facilities**, including subsurface infiltration.
  - **Shorelines**, creeks, streams, lakes, ponds, wetlands and other **bodies of water** along with their ordinary high water line and associated buffers on the site and within 100 ft. of property line.
  - **Steep slopes** greater than 15% and their associated buffers including cut banks greater than 4 feet. Indicate top and toe of Slope.
  - Waterfront projects shall show **all structures on adjacent properties.**
  - **Elevations** of all corners, wells, drainfields and infiltrations (use stub out as 0 ft. reference point)
